

TERMS OF USE

We ask you to carefully read this User Agreement, accept it in full and express unconditional agreement with it. Consent is expressed by clicking the "Register" button in the registration form. If you have not reached the age of 18 (eighteen) by clicking on the "Register" button, you confirm that you have received the consent of your legal representatives to perform such actions.

This User Agreement (hereinafter referred to as the Agreement) is a legal document concluded between an individual (hereinafter referred to as the User) and Quiz Mozgoboynya LLC: TIN 6685166710, PRSN 1196658059938, registered address: Yekaterinburg, Malysheva, 71, office 505 (hereinafter referred to as the Copyright Holder), which regulates the conditions and procedure for the User's participation in the online event "Mozgo Live" (hereinafter referred to as Mozgo Live), which is broadcast on the Website of the Copyright Holder - live.mozgo.com (hereinafter referred to as the Site).

1. Terminology

1.1 Intellectual online entertainment quiz "Mozgo Live" (hereinafter referred to as Mozgo Live) is a set of services of the Copyright Holder and a complex intellectual property that includes the online broadcast of the game Mozgo Live with the simultaneous demonstration of a multimedia product specially created by the Copyright Holder to conduct this event, as well as computer software for ECM access to which is provided through the information and telecommunication network Internet through the Website of the Copyright Holder www.mozgo.com. Exclusive rights to the game Mozgo Live belong to Copyright Holders.

1.2. **The Team (User)** is the collective subject of the Mozgo Live game, who have its own name, the captain, who make payment from one account, which may include several Players.

1.3. **Player** - an individual, an individual User, a direct participant in the game Brain Live.

1.4. **The user part of the Game** is a complex object that includes several results of intellectual activity (broadcast, multimedia product and computer program) to be used on a personal computer or other technical device of the User necessary for playing the Game.

1.5. **Game Rules** - a document establishing the rules for participation and behavior of the User in individual Games, as well as the responsibility of the User for violations. The rules of the game are located on the portal www.mozgo.com.

2. Subject of the agreement

2.1. The User, under the terms of this Agreement, takes part in the the Mozgo Live game, which is held in an online format on the Website of the Copyright Holder and is a complex intellectual property and a set of services of the Copyright Holder.

2.2 The Mozgo Live is not in any part the object of sale under this Agreement.

2.3 The user is not given the right to independently use the Mozgo Live for purposes other than those listed in Art. 3.3.2 of this User Agreement. The user participates in the Mozgo Live game exclusively on the terms of this Agreement and the Rules of the game.

2.4. The identification of each specific Mozgo Live game is done by announcing its conduction and notifying you of the possibility of registering on the live.mozgo.com website and / or by sending information messages to registered Teams (Users).

2.5 The copyright holder at any moment has the right to make changes to any component of the Mozgo Live game.

3. Scope of use

3.1 Participation in the game Mozgo Live is permitted only on the terms of this Agreement. Participation in the Mozgo Live game with violation (non-fulfillment) of any of the terms of the Agreement is prohibited.

3.2 The Copyright Holder provides the User with the opportunity to participate in the the Mozgo Live game for players located in any country in the world. Services are rendered remotely in a non-contact manner by organizing an event in a videoconferencing format. The place of services accomplishment is the city of Yekaterinburg, Sverdlovsk Region, Russian Federation.

3.3. The procedure of services accomplishment for providing access to participate in the Mozgo Live game is provided by the Copyright Holder:

3.3.1. The user is registered on the Site as a Team, to pay participation cost of the Mozgo Live game specified in the registration form for the game on the Site. Payment is made on the Website of the Copyright Holder in one of the proposed ways.

3.3.2. The user is obliged to participate in the Mozgo Live game for non-commercial purposes only to organize their own leisure.

3.3.3. To get an access to the Mozgo Live game, the user is registered in the appropriate form. During the registration process, the User is required to provide reliable data. All risks caused by the inaccuracy of the data specified in the form are borne by the User.

3.3.4. The user is obliged to familiarize themselves with the Rules of the game on the site of the Copyright Holder before paying the cost of participation in the the Mozgo Live game, is obliged to ensure the availability of the required technical equipment and special programs, and is also obliged to follow the instructions in the Game itself and take the necessary actual actions.

4. Limitations

4.1 The user does not have the right to use the Mozgo Live game for commercial purposes. Any retransmission of the Game, its recording and subsequent publication is prohibited.

4.2 The User Team may consist of 1 or more people. The number of team members is not limited if the User does not pursue the goal of commercial enrichment at the expense of such members.

4.3 Except for use to the extent and in the ways expressly provided for by this Agreement or the legislation of the Russian Federation, the User has no right to modify, decompile, disassemble, decrypt, or perform other actions with the content and components of the Mozgo Live game, with the aim of obtaining information about the implementation of the algorithms used in the Mozgo Live game, create derivative works using the Mozgo Live game.

4.4. The number of possible User participation in consecutive games of the Mozgo Live game is not limited.

4.5 It is forbidden to extract, copy and use the Mozgo Live game content elements, such as: text, graphic and design works, photographs, video clips, animation effects, fragments of phonograms and musical works, etc.

5. Intellectual Property Reservation

5.1 The set of intellectual rights of the Copyright holder for the Mozgo Live game is protected by the civil legislation of the Russian Federation and international agreements on security and protection of copyright, rights to individualization means, on the security and protection of intellectual property.

6. Procedure for concluding an Agreement and paying for participation

6.1 This Agreement is concluded at the time the User accepts the terms of this Agreement by installing a special symbol in the modal window when registering for the Mozgo Live game. The user assumes the obligation to comply with the terms of the Agreement from the moment of its conclusion.

6.2 The user becomes a participant in the Mozgo Live game from the moment of receipt of payment to the account of the Copyright Holder.

6.3 Having decided to participate in the Mozgo Live game, the User is registered for the game through a special form on the Site and pays for his participation. The cost of participation in the Mozgo Live game is set on the Site and is considered as a public offer.

6.4. The user pays for participation in the most convenient way of payment from those offered on the Site.

6.5. Funds paid as payment for participation in the Mozgo Live game are non-refundable, including if the User refuses to participate.

7. Responsibility of the parties and dispute resolution procedure

7.1 In the case of failure to fulfill or improper performance of obligations under this Agreement, the Parties shall be liable in accordance with the terms of the Agreement and the current legislation of the Russian Federation.

7.2 Any disputes and disagreements arising from relations governed by this Agreement shall be resolved by the Parties through negotiations and correspondence.

7.3 All disputes unsettled in the claim procedure arising in connection with the execution of this Agreement shall be settled in court in the Oktyabrsky District Court of Yekaterinburg, Sverdlovsk Region.

8. Limitation of liability

8.1 The Copyright Holder is not responsible for the actions of the User or third parties while participating in the Mozgo Live game.

8.2 The User understands and agrees that the Copyright Holder cannot guarantee that the Mozgo Live game will satisfy the subjective requirements and expectations of the User.

8.3 The Copyright Holder shall not be liable for direct or indirect damage, as well as the lost profit of the User or third parties as a result of the behavior or any actions of third parties during the participation in the Mozgo Live game.

8.4 The Copyright Holder is not responsible for the inability of the User to use the access granted to him if the User does not comply with the instructions and requirements set forth in the Rules of the game, including the technical means used by the User, special programs.

9. Final Provisions

9.1 The user is considered to have acceded to this Agreement and is obliged to properly fulfill his obligations throughout the entire term of the Agreement.

9.2 In all that is not provided for by this Agreement, the Parties are guided by the current legislation of the Russian Federation.

9.3 Any notifications sent by the Parties to each other on the basis of this Agreement or in connection with it shall be sent: for the Copyright Holder to the details specified in section 10 of the Agreement; for the User - to the details specified by the User in the registration form.
